She is very proud to have been accepted by TICA in February, 2001 as an Approved Specialty Judge, advanced to Provisional Allbreed Judge in 2004, and Approved Allbreed Judge in 2009. In her thirty plus years as a judge, she has judged in all over the United States and throughout the world. Her cattery, D'Alsan, has been home to Persians, Exotic Shorthairs, and Scottish Folds, with her first and most lasting love affair being with the smoke colors, and a special red tabby Persian, D'Alsan's Fiero, who was Cat of the Year for UCF in 1989. At the moment she is an active member of Coatimondi Cat Club of Phoenix, Arizona as well as serving as the President of Desperado Cat Fanciers, Inc. of Mesa, Arizona, both active TICA Clubs.
